#### Electric Vehicle and Infrastructure Credits/Rebates (in addition to the federal tax)

## NY DRIVE CLEAN REBATE

- Use: Reduce the costs of electric vehicles.
- Amount: Provides rebates up to \$2,000 for the purchase or lease of a new eligible EV price may vary based on a vehicle's all-electric range and manufacturer's suggested retail price.
- Eligibility:
  - » Be a four-wheeled motor vehicle manufactured for use on public streets, roads, and highways
  - » Have a gross vehicle weight rating of not more than 8,500 pounds
  - » Have a maximum speed of at least 55 miles per hour
  - » Be propelled at least in part by an electric motor and associated power electronics that draws electricity from a hydrogen fuel cell or battery that has a capacity of at least four kWh, and is capable of being charged by an external source of electricity

# NYSERDA DIRECT CURRENT FAST CHARGING (DCFC) PROGRAM

- Use: Reduce the cost of purchasing and installing DCFC stations
- Amount: Up to 80% of the purchase, installation, & certain operational costs of newly installed stations.
- Eligibility:
  - » Each site included must accommodate simultaneous charging for at least 4 vehicles at a minimum of 150 kW, and offer a total site delivery capacity of 600 kW or more.
  - » Each site must be within 12 miles of the Buffalo, Rochester or Syracuse city centers.
  - » At least one site location must be within the applicable city limits.
  - » At least 50% of sites must be in designated disadvantaged communities.

### NYS ALTERNATIVE FUELING INFRASTRUCTURE TAX CREDIT

- Use: Reduce the cost of purchasing and installing an electric vehicle charging station in public & workplaces.
- Amount: Income tax credit of up to \$5,000 or 50% of the cost of property
- Eligibility:
  - » Is located in NYS
  - » Is used 50% or more during the tax year in a trade or business carried on in NY
  - » Constitutes alternative fuel vehicle refueling or electric vehicle refueling property
  - » Has not been paid for from proceeds of grants before January 1,2015 including NYSERDA or NYPA

#### **UTILITY MAKE READY PROGRAM**

- Use: Reduce the infrastructure cost needed for installing Level 2/DCFC stations on business property.
- Amount: Range from covering 50% of eligible costs all the way up to 100%. Higher incentives available for sites in Disadvantaged Communities.
